

Our budget challenge

Our budget funds over 400 local services, from waste collection and street cleansing to libraries and museums. From fostering and children's services to adult social care for the vulnerable. Despite strong financial management, our budget for local services is under severe pressure and has been for over 10 years.

Why?

The central grant we receive from Government has reduced by over 90% in just over ten years and most of our funding for services now comes from local council tax, business rates and income from other fees and charges like car parking.

However, pressure and demand for services is rising higher than ever before, as is the cost of running our services.

Just like residents, the council is being impacted by inflation and rising fuel and energy prices. We're also seeing big increases in what providers charge to deliver services for us, most significantly the cost of placements to keep children safe and for local adult social care.

This increasing demand and cost of running council services is higher than the additional money we can raise through increases to council tax and other fees.

These factors create a large budget gap and is something all local councils

have been dealing with over many years. We must reduce our costs and increase income to balance the books.

Our budget challenge will also remain significant in the years ahead and further action will be needed in the longer-term.

For many years, we have been changing the way we deliver our services to balance our budget. The scale of the current challenge means that together we now face some very difficult choices

We are experiencing significant increased demands and costs for services such as adults and children's social care. These are services that we must provide by law and we spend around two-thirds of our total budget on them.

Our careful financial management through years of austerity means we are in good place to deal with these challenges and our reserves position is strong, but we have tough decisions ahead

Universal Credit. You may be able to get Universal Credit if you are on a low income or need help with your living costs. You could be:

- out of work
- working (including self-employed or part time)
- unable to work, for example because of a health condition

To claim you must:

- live in the UK
- be aged 18 or over (there are some exceptions if you're 16 to 17)
- be under State Pension age
- have £16,000 or less in money, savings and investments

Council tax reduction (CTR). Council tax reduction is a means tested council tax discount. How much support you will receive will depend on your income and circumstances.

Council tax disregards. Some adults in your household could be disregarded (not counted) for council tax purposes. These could include students, carers or residents in a care home.

To apply for student reduction, please go to the Citizens Access Council Tax portal. For all other exemptions, go to **my.southend.gov.uk** to complete the Cancel a Discount/Exemption form or call **01702 215001**.

Cost of living payments in 2023

Millions of households will receive payments of up to £900 made in three lump sums in 2023. Eligible households will be on one of the following benefits: Universal Credit, Income-based Jobseekers Allowance, Income-related Employment and Support Allowance, Income Support, Working Tax Credit, Child Tax Credit and Pension Credit. For each payment, exact payment start dates and eligibility criteria will be communicated by the Government before payments begin.

Essential Living Fund. The Essential Living Fund (ELF) is primarily intended to help vulnerable people live as independent a life as possible in the community. The fund is designed to:

- help people establish in the community following a stay in an institution, Care Home, Local Authority Care, hostel, prison or similar
- help people remain in the community rather than enter an institution or Care Home in which they will receive care ease exceptional pressures on people or their families
- help people with certain travel costs
- help people who are unable to meet their immediate short term needs either in an emergency in relation to some expenses or as a consequence of a disaster
- help children with school uniform costs

Pension Credit. If you are over the State Pension age and on a low income, this gives you extra support with your living and housing costs. If you receive Pension Credit you can also get other help, 'such as housing benefit, a council tax discount, help with heating costs and transport costs for hospital appointments

You can apply for Pension Credit up to four months before you reach the State Pension age.

If you have already applied for your state pension you can apply for Pension Credits by visiting apply-forpension-credit.service.gov.uk/start or by calling 0800 99 1234. Textphone: 0800 169 0133. Relay UK (if you cannot hear or speak on the phone): 18001 then 0800 99 1234.

WaterSure scheme. WaterSure scheme helps some people with their water bills. To apply for the scheme, you must be on benefits and need to use a lot of water either for medical reasons or because your household has a certain number of school-age children. You also need to be on a water meter or be waiting to have one installed.

You can apply for WaterSure by filling out a form from your water company. You will need to supply evidence that you qualify, such as a copy of your awards notice for a benefit.

Priority services registers. Vulnerable residents can sign up to this service with their energy company to ensure they get priority help and support if there is an issue if with their supply.

You can apply to sign up to this register by contacting your supplier or network operator. Information is available in a range of formats including braille, large print or different languages and more information can be found on the Office of Gas and Electricity Markets (OFGEM) website:

Benefits and support for those with children

15 hours free childcare for 2-yearold children

Families who have 2-year-old children and are on certain benefits can get 15 hours of free childcare a week.

15 hours free childcare for 3 and 4-year-old children

All families with children aged 3 and 4 can get 15 hours of free childcare a week.

30 hours free childcare for 3 and 4-year-old children

Eligible working families in England with 3 and 4-year-old children can receive 30 hours of free childcare a week.

Tax-free childcare for children aged 0–11 (0–16 if your child is disabled)

You can get up to £500 every 3 months (up to £2,000 a year) for each of your children to help with the cost of childcare.

Claim back childcare costs

You may be able to claim back up to 85% of your childcare costs if you're eligible for Universal Credit, with up to £646 back each month for one child or £1,108 for 2 or more children.

Free school meals. Children are entitled to receive free school meals if they or their parents or guardians receive certain benefits.

If you think you might be eligible for free school meals, submit a claim to your child's school.

You can get access to free activities and food for your children in the Christmas, Easter and Summer holidays if they are eligible for free school meals.

Food vouchers. For school aged children aged 4–15. Schools issue food vouchers for use during school holidays to families with children eligible for free school meals.

For children attending a pre-school, nursery or childminder aged 2-4: your childcare setting will issue food vouchers for use during school holidays to families receiving certain benefits.

This scheme will run to at least March 2023.

Child Benefit. You can claim Child Benefit if you're responsible for bringing up a child who is:

- under 16
- under 20 if they stay in approved education or training

Only one person can get Child Benefit for a child.

It's paid every four weeks and there is no limit to how many children you can claim for. You can claim Child benefit at www.gov.uk/child-benefit or call the Child Benefit helpline: 0300 200 3100.

Claim Healthy Start vouchers. If you're more than 10 weeks pregnant or have a child under four, you may be able to get help to buy healthy food and milk

Check if you're eligible for Healthy Start vouchers: www.healthystart. nhs.uk/how-to-apply or call 0300 330 7010.

Get help with maternity costs. You could claim a one-off payment of £500 to help towards the costs of having a child.

It's more important than ever that you are paying the correct amount of council tax.

Unsure of what council tax discounts/exemptions are available?

Think you are entitled to a discount – but unsure if you are receiving it?

Review your annual demand — all discount/exemption information is listed on the bill together with the calculation of the reduction.

I have a discount/exemption on my demand, but I am no longer entitled?

It's your responsibility to ensure you're claiming the correct discounts/ exemptions. Please visit

www.southend.gov.uk/CTaxExemption and complete a 'cancel discount/ exemption' form.

What happens if I don't make contact to update my account?

The Council regularly reviews all discounts claimed. If a discount is found to have been incorrectly claimed (or continued after a change of circumstances) you will be liable to pay a penalty charge and could face potential prosecution. The council tax charge will also be backdated.

Single person discount errors?

It is a common misconception that a single parent with adult children living with them can continue claiming a single person discount. This is not correct, as single person discount is only ever applicable if there is only one person over the age of 18 living in a property.


RECYCLING AND WASTE **COLLECTION SERVICES**

- ✓ Place it on the edge of your land, in clear view and in an accessible location.
- ✓ Should there be no space on your land, present it against the wall of your property.

So much more beside the seaside, beside the sea

Seven of our parks have been awarded the prestigious Green Flag, including Shoebury Park and Southchurch Hall Gardens. As well as somewhere to have picnics and play on the swings, our parks host events like Park Runs through to the Leigh Folk Festival at Library Gardens, and free music at Priory Park bandstand. Chalkwell Park is home to Metal, and Prittlewell Priory, the 12th Century Cluniac Monastery is based at Priory Park.

Open spaces are plentiful too, with Two Tree Island and Belfairs nature reserves the perfect place to spot local wildlife.

Great outdoors not for you? Visit Central Museum, home to Southend Planetarium, artefacts from the Prittlewell Prince who was buried here during Saxon times, and The London shipwreck which sank in the Thames Estuary in 1665. Our Letters Patent signed by Her Late Majesty confirming city status is also on show. Next door, the Beecroft Art Gallery has a permanent collection of over 2,000 historic and contemporary works.

Focal Point Gallery in the city centre is also home to exhibitions and somewhere to immerse yourself in the work of both local and national artists.
